1. Faxes, documents and data

2. Document Analysis

InteleFiler's automated indexing incorporates Optical Character Recognition (OCR) to scan documents as they arrive against a repository of templates, finds matches and performs the heavy lifting of populating your EHR automatically or if preferred with human validation.



3. Your Workflow Rules Applied Automatically

InteleFiler indexes critical information and applies workflow rules to place document and discrete data into your patient's chart. Manual tasks such as order management, physician tasking, and closing workflow and lab orders are automated by InteleFiler, allowing your staff resources to be utilized more effectively.



4. Document Validation, Indexing, and Import

Our document validation process ensures that all of your documents are properly captured, reviewed for accuracy, and indexed directly into your EHR.
